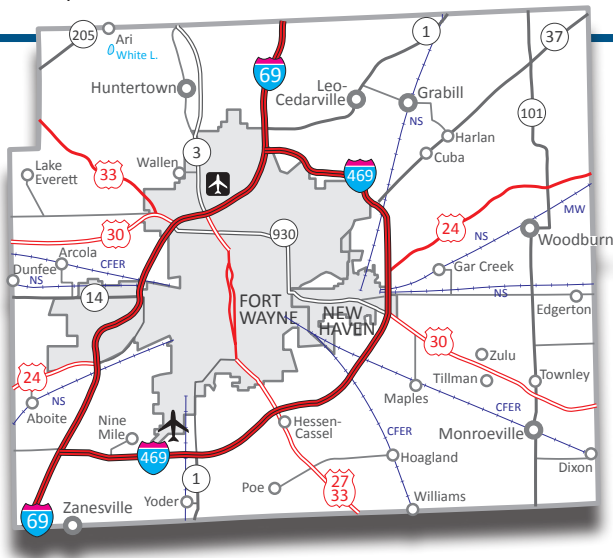

### FARM BUSINESS

Almost 14.8% of all farms in Northeast Indiana (EGR3) are located in Allen County, while comprising only 13.0% of farmland in Northeast Indiana.

Allen County also makes up the following for Northeast Indiana:

- 13.4% of all harvested cropland
- 11.8% of all sheep and lamb inventory
- 22.3% of all wheat for grain
- 29.4% of all oats for grain
- 14.6% of all soybeans
- 19.4% of all non citrus farms
- 22.5% of all apple farms
- 28.0% of all nut farms
- 12.9% of organic farms
- 13.7% of all corn for grain

Allen County is also involved in the production of sorghum, milk goats, bees and honey, horses and ponies, hay, fruits and nuts, and vegetables.
